4. FIRST AID MEASURES

- Skin contact : Wash off immediately with plenty of water for at least 20 minutes. Immediately remove contaminated clothing, and any extraneous chemical, if possible to do so without delay.
- Ingestion : Never give anything by mouth to an unconscious person. If a person vomits when lying on his back, place him in the recovery position. Prevent aspiration of vomit. Turn victim's head to the side.
- Inhalation : If breathing has stopped or is labored, give assisted respirations. Supplemental oxygen may be indicated. If the heart has stopped, trained personnel should begin cardiopulmonary resuscitation immediately. Move to fresh air.

- Specific hazards : Incomplete combustion may form carbon monoxide. Potential dust explosion hazard. As discussed in NFPA 68 and NFPA 69 standards, mixing any dust that can propagate a deflagration with flammable vapor will increase the hazard rating. Where explosive dusts are contained in equipment, that equipment should contain adequate explosion relief vents, explosion suppression systems, or an oxygen-deficient atmosphere. Care should be taken to prevent the escape of dust from horizontal surfaces. Downwind personnel must be evacuated.
- Special protective equipment for fire-fighters : Use personal protective equipment. Wear self contained breathing apparatus for fire fighting if necessary.
- Further information : The product, as distributed, is noncombustible.

6. ACCIDENTAL RELEASE MEASURES

- Personal precautions : Wear suitable protective clothing, gloves and eye/face protection. Use self-contained breathing apparatus and chemically protective clothing. Evacuate personnel to safe areas.
- Methods for cleaning up : Approach suspected leak areas with caution. Contact Air Products' Emergency Response Center for advice. Place in appropriate chemical waste container.

7. HANDLING AND STORAGE

Handling

Avoid dust formation. Do not breathe vapors/dust. Emergency showers and eye wash stations should be readily accessible. Adhere to work practice rules established by government regulations. Avoid contact with eyes. Use only in well-ventilated areas. Use personal protective equipment. When using, do not eat, drink or smoke.

Storage

Keep containers tightly closed in a dry, cool and well-ventilated place. Store at room temperature in the original container. Store under a nitrogen atmosphere. Keep away from heat.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

Engineering measures

Provide readily accessible eye wash stations and safety showers.
Provide natural or explosion-proof ventilation adequate to ensure concentrations are kept below exposure limits.

Personal protective equipment

- Respiratory protection : Respirator must be worn if exposed to dust. Wear appropriate respirator when ventilation is inadequate. Use a NIOSH/MSHA approved full-face respirator with acid gas cartridges.
- Hand protection : Impervious gloves.
The breakthrough time of the selected glove(s) must be greater than the intended use period.

Chronic Health Hazard

Boron compounds (particularly boric acid) have caused anemia, and adverse liver, kidney, central nervous system and reproductive effects. Testicular atrophy, reduced sperm counts, abnormal sperm and sterility have been observed in mice, rats and dogs fed at a daily level of 45 mg/kg of body weight based on boron product equivalents. Oral administration of boric acid to pregnant mice, rats and rabbits has caused increased incidences of fetal death and malformed offspring.
